1. Types of Information We Collect

We do not collect Special Categories of Personal Data, such as philosophical beliefs, sex life, sexual orientation, political opinions, trade union membership, health information, genetic and biometric data, criminal convictions, or offenses.

Types of Information We Collect

We may collect the following categories of personal information:

- Identifiers: Such as names, addresses, email addresses, telephone numbers, or other communication addresses.
- Demographic Information: Including age group, birthdate, and gender.
- Commercial Information: Relevant to lifestyle, interests, activities, purchasing tendencies, and order history.
- Location Information: Including country, city, or neighborhood, and more specific location information provided through GPS functionality.
- Financial Information: Collected for processing payments, encompassing payment card details.
- Internet and Network Activity Information: Covering browsing behavior, search history, and interactions with websites and advertisements.

2. How Deals Drive L.L.C- O.P.C Gathers Information

Information Collection from Various Sources:

Password-Linked Purchases: For purchases made without a password, we link them to your email address, creating a secure account. If you later create a password, you can view past purchases associated with that email address.

Legal Basis for Data Processing: We use your personal data in compliance with the law, typically for contract performance, legitimate interests, legal obligations, or with your consent. 5. Security of Personal Information
